

Release and Acknowledgement of Risks

I, _____, as lessee (Customer), understand and acknowledge that the activity to be engaged in through my rental of an inflatable, interactive amusement device, and/or any other item being rented, brings with it both known and unanticipated risks to myself and my guests. Those risks include, but are not limited to falling, slipping, crashing and colliding, and could result in injuries, illness, disease, emotional distress, death, and/or property damage to myself and/or my guests. I voluntarily release, indemnify, hold harmless and discharge J & S Entertainment, L.L.C. from any and all liability, claims, demands action, or right of action whether personal to me or to a third party which are related to, arise out of or are in any way connected with any rental of the unit (bouncer), including those allegedly attributable to negligent acts or omissions. I agree to reimburse any reasonable attorney fees and costs which may be incurred by J & S Entertainment, L.L.C. in the defense of any such liability claim, demand, action, or right of action.

I acknowledge that I have the adequate homeowners insurance, tenant insurance or other liability insurance to cover any bodily injury which might occur to myself or my guests from the use of the equipment I am renting and I agree to bear the cost of such injuries myself. I agree to bear all cost of replacing any rental equipment that is stolen, lost, and/or damaged and that such replaced/repared equipment will be the property of J & S Entertainment, L.L.C.

In the event I elect not to retain an Operator, I agree to have an adult supervise both the equipment and its use at all times while equipment is in my possession. A set of rules and directions are displayed in front of the bouncer and the driver will also explain the safety rules which I agree to follow and utilize at all times during the operation and use of the unit (bouncer) and/or equipment. I understand that if no operator has been left with the unit then I am solely responsible for the correct and safe operation of this equipment. I voluntarily agree to keep and maintain all safety rules that have been explained by the driver and rules listed on bouncer. I understand that there must be a clear path to where the unit (bouncer) will be set up and that driver will not set up the unit if there is not and delivery will be cancelled. Also all animal droppings need to be picked up prior to delivery. I understand that Bouncers shall be inflated at all times until driver comes so that the bouncer can be inspected for damage. I agree to keep the equipment located at the address listed below during the rental and ensure it is not removed. I understand I am responsible for all the equipment until it is picked up by the same driver.

I acknowledge that I and the driver have inspected the equipment prior to delivery and it is in working order and if not the driver has been informed of any deficiencies. By signing at the bottom, I acknowledge that I am satisfied with the equipment and accept it for the duration of the rental agreement. I understand that problems do arise at times and if there is any problem I agree to contact the office so someone can be sent out to repair or take care of the problem.

I understand that if it rains/snows or winds become strong before my party, J & S Entertainment, L.L.C. reserves the right to cancel delivery. If it rains/snows or winds become strong during my party, J & S Entertainment, L.L.C. reserves the right to pick up the rental equipment and no refund will be given. I understand that I will be informed of this policy over the phone, in person, and/or in writing if there is a chance of bad weather in the forecast.

I acknowledge and certify that I have had sufficient opportunity to read the entire document, that I understand its content and that I execute it freely, intelligently, and without duress of any kind and agree to its terms. I further warrant and represent that I am either the customer named below, or I am authorized and empowered to accept delivery of the equipment and to sign this agreement on their behalf. Further, I agree that I am also binding myself personally as an additional party to all of the terms and conditions of this agreement. I acknowledge that I am 18 years of age or over. I understand that I.D. must be seen by driver and that if no I.D. is available, driver will not deliver the unit (bouncer).
